June 22, 2021



RFP RESPONSES

- ▲ RFP Responses were received from 7 PBMs: Express Scripts (Incumbent), Level Care /Express Scripts, Aetna, Optum/Coretrust, Amerihealth, Ingenio and Magellan.
- Selected Semi-Finalists were: Express Scripts (Incumbent), Level Care/Express Scripts, Aetna and Optum/Coretrust.
- Selected Finalists are Level Care/Express Scripts and Aetna.
- All PBMs proposed Traditional pricing.
- ▲ All bidders were required to submit a claims repricing and respond to 102 Business & Contract Requirements that normalized the pricing, contract terms, conditions, and definitions across all bidders.



Key Factors To Consider

- ✓ Pricing:
 - Contractual Pricing and guaranteed ingredient costs and dispensing fees
 - Administrative fees and implementation credits
 - Rebate structure and guarantees
 - Specialty medication coupon and patient assistance programs to lower specialty cost
- ▲ Level of Member disruption to achieve cost savings
- Contractual provisions guarding against gaming that could negatively impact results
- Clinical programs to assure proper utilization and maximize cost control
- Customer service ability & reputation
- Length of contract and ability to term

FINANCIAL SUMMARY - ANNUALIZED

- Aetna provided the best financial offer with 19.52% savings; 7.38% greater than the ESI (Incumbent) Renewal offer.
- Level Care / ESI provided 15.66% savings while continuing to provide ESI as the PBM.
- When Specialty Financial Assistance programs are included, both Level Care/ESI and Aetna represent savings at approximately 20% each.
- All PBMs offer excellent service models.
- Level Care/ESI has guaranteed no Formulary Disruption. Aetna's negative disruption is estimated at 3.17% of claims.
